1. Review/Establish a Fee for Retail Sale of City Potable Water for Ice and Water Vending Machines

The Committee briefly discussed this topic and decided unanimously to remove it from the agenda.

### New Business

### 1. Review/Discuss Amendment to Sign Ordinance

The Committee reviewed and discussed the amendments needed to the sign ordinance. The changes are:

Remove - 96.09 (C) (1) Residential marketing signs, on- and off-site: 12 months, renewable on a six-month basis thereafter. (2) Commercial or industrial marketing real estate signs: 12 months, renewable on a six- month basis thereafter.

Reword / Add ó 96.09 (3) Temporary event commercial or mobile signs including banner flags: advertising a special sale or event, not to exceed 30 days and not more than four times per

calendar year with at least 30 days in between such advertising periods. No more than two temporary <u>event</u> signs shall be allowed per multi-tenant building.

Remove / Add 96.09 (D) Every applicant for a temporary sign shall pay a fee of \$50 per sign (to include both sides of double faced signs). No fee shall be charged for temporary sign permits for not for profit activities or organizations. Penalty, see Section 96.99. The safety and maintenance of temporary event signs shall be as provided in Section 96.14.

Alderman L. Hall made a motion and Alderman Evans seconded to approve the changes to Chapter 96, Signs and bring it to the March 16, 2016 Finance, Administration and Land Acquisition Committee meeting for final review.

Upon voice vote, THE MOTION CARRIED, 4 yes

#### **Adjournment**

With no further business before the Committee, Alderman L. Hall made a motion and it was seconded by Alderman Evans to adjourn. Upon voice vote, THE MOTION CARRIED unanimously and the meeting was adjourned at 7:00 p.m.
