The minutes were reviewed. Alderman Tutor made a motion and Alderman L. Hall seconded to accept the December 8, 2015 Committee meeting minutes as written and have them placed on file.

Old Business

No Old Business was discussed.

New Business

1. Awnings for Police Department

Chief Arnold explained to the Committee that he is in the process of obtaining quotes for new awnings, along with installation. This will be discussed at a future meeting.

2. Narcan Mandate

Chief Arnold informed the Committee that it was recently mandated that all Police Officers carry Narcan on their person while on duty. Narcan is an opioid antagonist and is used for the complete or partial reversal of opioid overdose, including respiratory depression. Officers, usually the first to arrive at the scene, wongt have to wait for an ambulance to administer the drug that could possibly save the life of someone overdosing on heroin or other opiates. A dose of Narcan is designed to keep someone alive so they can be transported to the hospital. All Officers are required to take a 4-hour training class prior to carrying Narcan.

3. Traffic Trailer Update

Chief Arnold let the Committee know that the traffic trailer arrived and has been out in several locations counting traffic and speeds traveled.

Review FY2016 Budget Reports

Police Department ó Chief Arnold discussed the departments FY2016 budget with the Committee.

ESDA ó Director Housman discussed the budget with the Committee. Director Housman also handed out a list of call-outs from 2015.

Adjournment

With no further business before the Committee, Alderman Tutor made a motion and it was seconded by Alderman L. Hall to adjourn. Upon voice vote, THE MOTION CARRIED unanimously and the meeting was adjourned at 5:50 p.m.
