Joie - Here is the exhibit for the WSSA Meeting for the ADA Sidewalk Completion Project.

Zoning breakdown is for discussion and is currently as follows:

Zone 1: East of Kankakee River and South of Kahler Road to City limits.

Zone 2: East of Kankakee River, North of Kahler Road both sides of Fulton Street/Shakespear Street/S. McIntyre Street,

South of Route 53, East to City Limits.

Zone 3: City limits to the west and south, east to Kankakee River/ Fulton/Shakespear/S. McIntyre and south of Route 53

to the north.

Zone 4: City limits to the west, North and west to Route 53, south of Kankakee River Drive and out and including O'Brien

Subdivision.

Zone 5: North of Kankakee River Drive, City limits to the west, north of Foxtail Commons/Deer Creek Subdivision/USCS

and out to and including Water's Edge Subdivision.

This project will address any and all required ADA ramps, curb depressions, sidewalk sections that need to be installed, completed and/or corrected (i.e. tripping hazards).

Each Zone is proposed to have 24 months to be completed.
